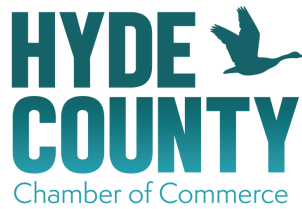

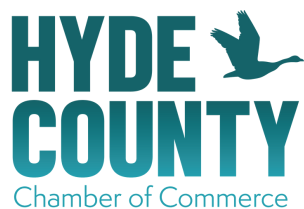

TERMS & CONDITIONS

- **VENDOR REQUIREMENTS:** The Hyde County Chamber of Commerce is searching for vendors to help promote and maintain the true essence of what Farm Days were intended to be since it was first erected -- agriculture awareness, farm safety, locally grown produce, handmade arts and crafts, etc.
- **VENDOR FEES:** All fees must be paid on or before September 9, 2022 by the close of business (5pm). \$50 per booth. Checks can be dropped off at the local Cooperative Extension Office (30 Oyster Creek Road Swan Quarter, NC).
- **BOOTHS:** All booths will be reserved a 10ft x 10ft space. Tents, tables, chairs, and electricity will NOT be provided.
- **BOOTH VOLUNTEERS:** Booths are allowed to have volunteers, but they must pay admission fees into Farm Days event. If approved to be a vendor you will only be granted one general admission ticket without a wristband for rides.
- **BOOTH HOURS:** Upon approval, all vendors must agree to have their booth open for the entire duration of the event whether rain or sunshine. The event will be held on Saturday, October 22, 2022 from 10am - 6pm. Booth setup will be from 7am-9am on the day of the event. If breakdown occurs before the end of the event this will be a breach of our terms and conditions and will put your organization in jeopardy of receiving approval for a booth the following year at our Farm Days event.
- **CLEAN-UP & SANITATION:** Vendors are required to keep booth area clean and tidy. All trash and items must be picked up at all times and properly disposed.
- **ADVERTISING:** All advertising must be professional, non-graphic, non-political, and kid-friendly. Please have all pricing structures visible and legible to patrons.
- **ENTERTAINMENT:** Vendors are prohibited from playing music at their booth.
- The Hyde County Chamber of Commerce Farm Days Committee reserves the right to amend or add any rule without notice.
